ART. 1 – PURPOSE AND OBJECTIVES OF THE MA TER

The Telematic University of Giustion Fortunato establishes for the year Academic 2023/24, the Master First level university degree in "Aviation Management", pursuant to art. 3, paragraph 9, of the Ministerial Decree. October 22, 2004, n.270 and subsequent amendments/integrations and in compliance with the 1st and 2nd level University Master's Regulations. Today's aviation industry offers many challenging career opportunities. While the systems of tran sport plane increase in sophistication, airlines are looking for figures professionals capable of responding to the needs coming from the sector who possess an optimal mix of academic knowledge and aviation skills. The master has a curriculum that delves into the application of modern practices to the special challenges of air transport companies. The course work intertwines training on traditional economics and management with an understanding of the characteristics unique and specific to the aviation sector. The curriculum is in fact oriented towards the needs of strategic decision makers in the sector of aviation management allows flexibility for specialization in different fields of air transport. Thanks to the training course, students will acquire specific professional skills that are fundamental for developing ideas, projects, actions and strategies in the commercial aviation sector. The Master provides all the necessary knowledge and skills in Competition Law, Management operations, economics and marketing, cyber security, professional communications and communications technique, transport geography.

ART. 2 - RECIPIENTS

Recent graduates and young professionals who want to develop a career in commercial aviation. Holders of a degree obtained according to current legislation and prior to the application of the Ministerial Decree can participate in the Master's course. 509/99.

ART. 3 – DURATION, VENUE AND FREQUENCY OF THE COURSE

The University Master has an annual duration for a teaching load of 1500 hours corresponding to 60 CFU. Attendance by those enrolled in the course activities is mandatory and will be obtained via tracking on the platform. To obtain the qualification, attendance equal to 80% of the total duration of the course is require

The online form will take place through the connection to the platform Unifortunato where the student will be able to access the teaching material and take lessons. The student's access to the Unifortnato platform will take place via a userid and a password. The platform Unifortunato records the student's activities in compliance with the rules relating to the processing of personal data (Legislative Decree 196/2003). The platform and the assistance and tutoring services operate in compliance with the requirements set out in the Ministerial Decree 17.4.2003.



There will also be in-depth face-to-face seminars on particularly relevant topics with compulsory attendance at at least one seminar.

ART. 4 - COURSE PROGRAM

The Master is divided into modules, for a total of 60 ECTS which include specific topics, functional to the reference disciplines according to the following table:

Module II: Innovation and project management for aviation – (SECS-P/08) 4 CFU

Module III: Human resource management and organizational leadership - (SECS-P/08) 6 CFU

Module IV: Finance for aviation – (SECS-P/07) 6 CFU

Module V: Aviation management – (SECS-P/07) 6 CFU

Module VI: Communication and Research methods – (L-LIN/12) 3 CFU

Module VII: Geography, transport and infrastructure – (M-GGR/02) 8 CFU

Module VIII: Risk and Safety Management Systems – (SECS-P/07) 6 CFU

Module IX: Principles of Economics Aviation Marketing – (SECS-P/08) 4 CFU

Module X: Competitive strategies and performance in aviation industry – (IUS/05) 9 CFU

Final exam: 6 cfu

Art. 5 - REGISTRATION FEE AND MASTER'S MANAGEMENT

The registration fee is Euro 2,700.00. The first installment of \notin 900.00 must be paid upon registration; the second installment of \notin 900.00 within two months of registration and the third installment of \notin 900.00 within five months of registration.

The student who is not up to date with payments will not be able to access the e-learning platform and the final test to obtain the qualification



ART. 6 - ENROLMENT FEE AND MANAGEMENT OF THE MASTER'S DEGREE COURSE

Admission to the Master requires completing the admission/registration form, which can be downloaded online and attached to this announcement; the form must be sent by 31 December 2023 via registered mail with return receipt, to the following address: Giustino Fortunato Telematic University, Student Secretariat, Viale Raffaele Delcogliano n. 12, 82100 – Benevento. Only if the price reaches at least minimum number of registrations, the student secretariat is allowed to accept further registrations, even if submitted late, as long as they are made by the official start date of the Course.

The registration application must be accompanied by the following documentation:

The activation of the Master is conditional on reaching the minimum number of participants set at 20. Therefore, if the Master is not activated, the course will be entitled to a refund of the sum paid upon registration.

ART. 8 – FINAL TEST

At the end of the Master's degree, those enrolled who have fulfilled the attendance obligations, passed the tests relating to the various disciplines and supported the dissertation of a final paper, will be awarded the first level university Master's diploma in "Aviation Management", equivalent to 60 C.F.U. usable in accordance with current legal provisions.

6 Data retention period

Within the scope of the purposes indicated above, your personal data will be retained for the duration of the contract and for the ten years following the period in which the Data Controller is subject to conservation obligations for fiscal, contractual, or other impositions established by according to law or regulation or for the purposes already indicated, after this period, if not expressly reconfirmed by the interested party, they will be deleted.

7. Data transfer

The management and storage of data will take place on servers located within the non-state University "Giustino Fortunato" for the purposes referred to in point 4 of this information. A backup copy of the data is present on the Aruba servers located throughout the country.

Pursuant to art. 45 GDPR, the transfer of personal data may take place to a third country or an international organization if the Commission has decided that the third country or international organization in question guarantees an adequate level of protection or other adequate guarantees provided for by the GDPR. This transfer will take place if the student decides to participate in Erasmus, training courses abroad, etc

8. Rights of the interested party
